This vehicle must meet current BMW Certified guidelines for transfer eligibility:

- Vehicle must have originally been sold as BMW Certified on or after January 1, 2014.
- At time of proposed transfer, the BMW Certified Limited Warranty must be in effect, that is, the vehicle is within age & mileage limits.
- Vehicle must not have been totaled, stolen, exported from the US, or imported to the US from another country.
- The BMW Certified Limited Warranty is only eligible to be transferred from private owner to private owner.
- Transfer must be requested by the Buyer of the BMW Certified vehicle.
- Transfer application must be submitted by the BMW Certified Buyer within 60 days of vehicle sale.
- Dealership participation is excluded.

BMW of North America, LLC reserves the right to refuse transfer in the case of fraud, abuse, failure to meet transfer guidelines, or if the appropriate documentation is not submitted.
